Sales turnover must also include all South African subsidiary companies or firms controlled by the member and engaged in the industry. Turnover must also include any more recent business acquisitions which will benefit from your membership during the year of membership.

\*The Industry: industry sales include all activities connected with the manufacture of coatings; paints; powder coatings; printing inks; artists colours; varnishes; lacquers; stains; wood preservatives; thinners; strippers and allied products and other like protection or decorative products.
